Why Comprehensive Plans?

Statutory Purpose:

* NMSA in 1978, Section 3-19-9(A):

"To guide and accomplish a coordinated, adjusted and harmonious development of the City, which will, in accordance with existing, and future needs, best promote health, safety, morals, other, convenience, prosperity or the general welfare, as well as efficiency and economy in the process of development."





Why a Comprehensive Plan Update?

The Comprehensive Plan was adopted in 2017

- Update every five years to stay current
- This update is <u>not</u> to bring in new policies and actions, but instead bring in policies that have been approved and accepted
